- CITATION BY ARMY ORDER FOR THE 4TH AMERICAN BRIGADE 22 OCTOBER 1918. For its performance during the Battle of Belleau Wood. This is a copy of the original citation. It is in French with an English translation.
- Certificate of award of Distinguished Service Cross to John Kukoski for heroism at Chateau Thierry 6 June 1918. John Kukoski was assigned to the 49th Company, 5th Marine Regiment. This is a copy of the original certificate.
- Certificate authorizing Albert Powis to wear the Verdun medal for his actions during St. Mihiel and Meusse-Argonne Offensives. Albert Powis served with the 66th Company 5th Marine Regiment. The certificate is in French.
- Certificate from the United States Marine Corps in grateful memory for Pvt. Frank E. Anderson’s sacrifice of his life 1 November 1919.
- Discharge paper for Pvt Pearly Demoure delivered 31 May 1919. Pvt Demoure was wounded in action at Argonne Wood November 1918 and was medically discharged. Discharge Papers for Pvt John James Hale USMC. 13 August 1919. This is a copy. Pvt Hale served from 19 July 1918 to 13 August 1919. He served in France, Belgium, Luxemburg and Germany. He was part of the March of the Allied Armies across the Rhine River and the Occupation of Germany. Letter to Pearly Demoure for entitlement of a Purple Heart for wounds received in France 31 October 1918. Pvt Demoure was wounded in the arm while assaulting a German machine gun emplacement on 31 October 1918.
- Notification of Award of Navy Cross to Pvt John Kukoski USMC. Pvt Kukoski received the Navy Cross for his attack on and capture of a German machine gun along with its crew at Chateau Thierry on 6 June 1918.
